For renewable energy - Our energy portfolio must show that 15% of our energy is sourced from a clean energy based production through 2029, and it goes up from there. Our current portfolio is 20%! We are ahead of the legislation.

In the way of energy waste reduction - Beginning in 2026, energy waste reduction programs (such as rebates) shall collectively achieve incremental energy savings equivalent to 1.5% of total retail electric sales from the preceding year. We have many programs available to help us reach this goal.

One way we do our part to help energy waste is by offering a free home energy check-up. An expert will perform a thorough check of your home to find ways for you to save energy, lower expenses, and install energy-saving measures such as LED lights, faucet aerators, high efficiency showerheads, nightlights, pipe wrap and more, during the visit.

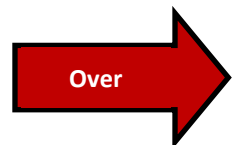
