Bay City Electric Light & Power's Clean Energy Program is offering a rebate up to **\$50.00** on qualifying Central A/C tune-ups for residential customers. Rebates are available for single family homes, condos, or townhouses. Funds are limited and paid first-come, first-serve. This program runs **May 1 - September 30, 2026** and is limited to one central a/c tune-up incentive every 5 years.

- Units 2 ton or greater = **\$50 rebate**
- Units less than 2 ton = **\$25 rebate**

- Complete rebate on the reverse side
- Attach receipt indicating type of service performed and amount paid
- Contractor information is required
